SECTION 4: FIRST AID MEASURES

4.1 Description of first aid measures

General notes

Never give anything by mouth to an unconscious person. Place patient in recovery position and ensure airway patency. When in doubt or if feeling unwell seek medical assistance. Show the safety data sheet and label to the physician. No action shall be taken involving any personal risk or without suitable training. It may be dangerous to the person providing aid to give mouth-to-mouth resuscitation. Following skin contact

4.2 Most important symptoms and effects, both acute and delayed

Following inhalation

Excessive exposure to spray mist, fog, or vapours may cause respiratory irritation.

Following skin contact

Itching, redness, pain. May cause sensitisation by skin contact (itching, redness, rashes).

Following eye contact

Contact with eyes can cause irritation (redness, tearing, pain).

Following ingestion

May cause nausea/vomiting and diarrhea. May cause abdominal discomfort. Irritates mucous membranes in the mouth, throat, esophagus and in gastrointestinal area. Aspiration into the lungs causes coughing, shortness of breath and may lead to chemical pneumonia.

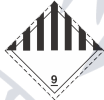
