SECTION 4: FIRST AID MEASURES

4.1 Description of first aid measures

General notes

Never give anything by mouth to an unconscious person. Place patient in recovery position and ensure airway patency. When in doubt or if feeling unwell seek medical assistance. 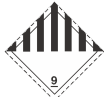
