It may be dangerous to the person providing aid to give mouth-to-mouth resuscitation. When it is suspected, that there may still be harmful vapours/fumes present in the air, respiratory protection (mask; self contained breathing apparatus) must be used. Wash contaminated clothing with water before removing or use gloves.

Following inhalation

Remove patient to fresh air - move out of dangerous area. In case of unconsciousness bring patient into stable side position and seek medical attention. If breathing is irregular or respiratory arrest occurs, provide artificial respiration. Keep at rest in a position comfortable for breathing. Seek medical help immediately.
