General notes

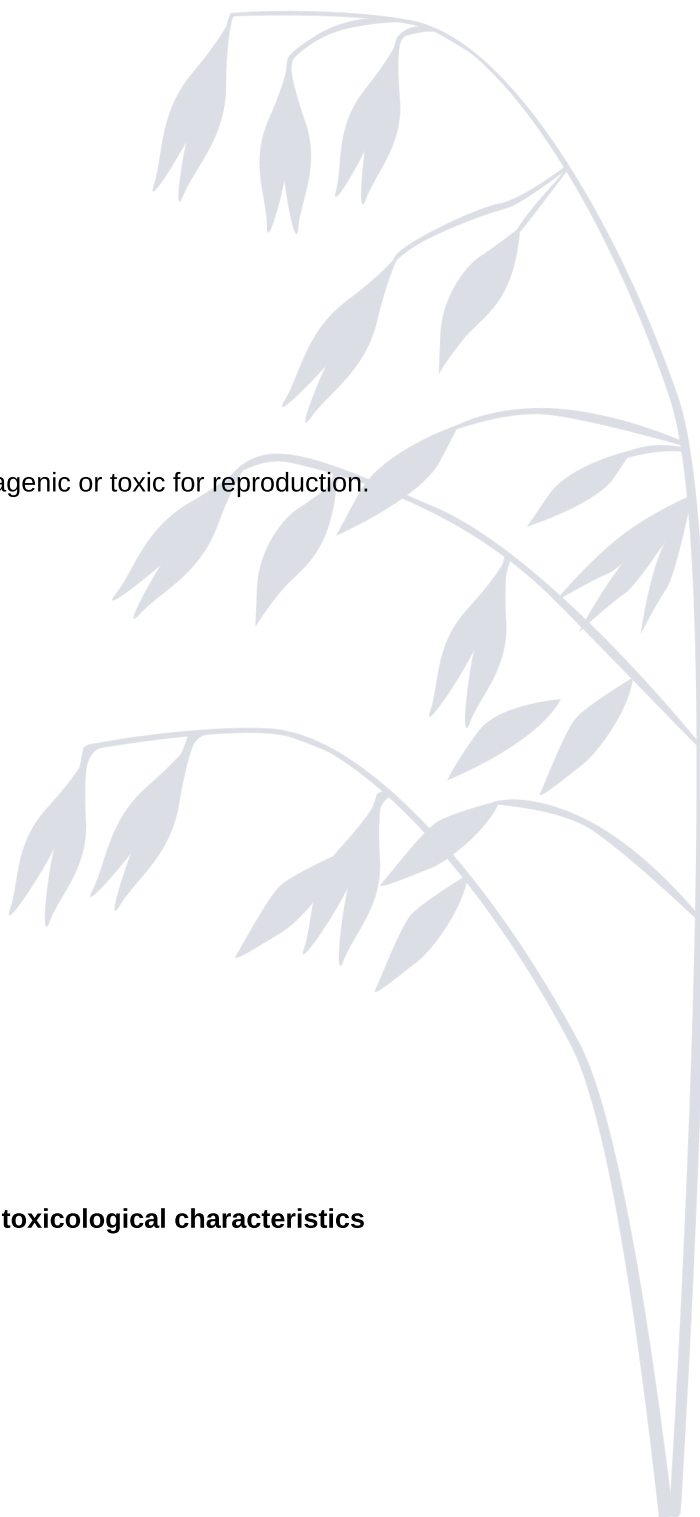
