Never give anything by mouth to an unconscious person. Place patient in recovery position and ensure airway patency. When in doubt or if feeling unwell seek medical assistance. Show the safety data sheet and label to the physician. No action shall be taken involving any personal risk or without suitable training. It may be dangerous to the person providing aid to give mouth-to-mouth resuscitation. When it is suspected, that there may still be harmful vapours/fumes present in the air, respiratory protection (mask; self contained breathing apparatus) must be used. Following inhalation

Remove patient to fresh air - move out of dangerous area. In case of unconsciousness bring patient into stable side position and seek medical attention. 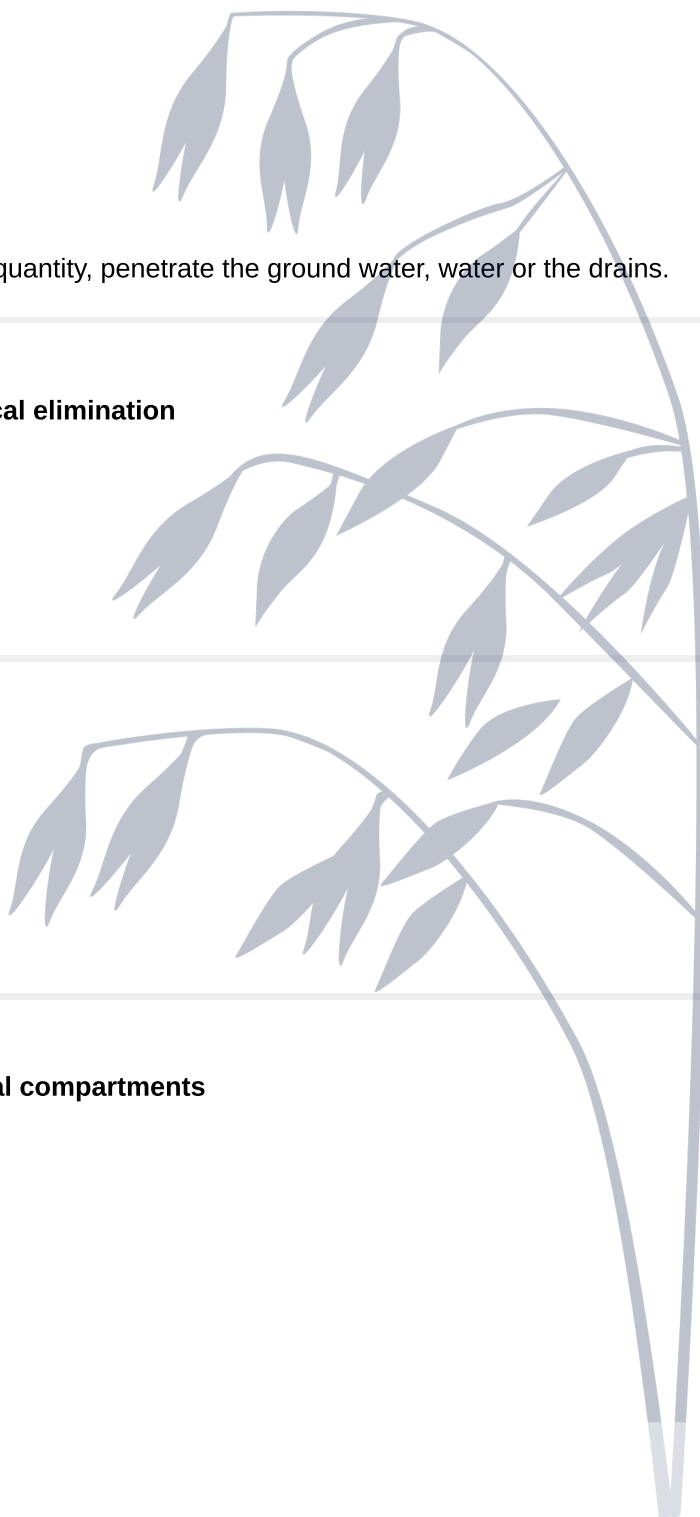
