SECTION 4: FIRST AID MEASURES

4.1 Description of first aid measures

General notes

Never give anything by mouth to an unconscious person. Place patient in recovery position and ensure airway patency. When in doubt or if feeling unwell seek medical assistance. Show the safety data sheet and label to the physician. No action shall be taken involving any personal risk or without suitable training. It may be dangerous to the person providing aid to give mouth-to-mouth resuscitation. When it is suspected, that there may still be harmful vapours/fumes present in the air, respiratory protection (mask; self contained breathing apparatus) must be used. Following inhalation

Immediately flush eyes with running water, keeping eyelids apart. Seek medical help.

Following ingestion

Do not induce vomiting! Aspiration hazard if swallowed. Can enter lungs and cause damage. If vomiting occurs, the patient should hold the head lower than the hips, because it reduces the possibility of aspiration. Rinse mouth thoroughly with water. Never give anything by mouth to an unconscious person. Immediately consult a doctor. Show the physician the safety data sheet or label.

4.2 Most important symptoms and effects, both acute and delayed

4.3 Indication of any immediate medical attention and special treatment needed
