2. OLFACTORY CLASSIFICATION AND ODOUR PROFILE

Oranger Base is a synthetic perfume base developed to recreate the complete odour profile of the orange tree. It combines three essential facets: blossom, leaf and fruit peel.

The profile is fresh and citrus-floral, with a soft neroli character and a recognisable green-woody petitgrain nuance. Bright citrus freshness is balanced by the floral softness of orange blossom and the drier aromatic character of the leaf.

3. FUNCTION IN A FRAGRANCE COMPOSITION

The base acts across the top and middle notes. It links a bright citrus opening with the floral heart, while its petitgrain facet adds green, dry and natural depth. Lower levels provide freshness and a floral nuance; higher levels can form a dominant citrus-neroli accord.

4. APPLICATION AND COMPATIBILITY

Oranger Base is suitable for citrus-floral compositions, neroli and petitgrain accords, orange blossom fragrances, fresh Mediterranean perfumes, Cologne compositions, classic structures, modern unisex fragrances and aromatic-citrus formulations.

It blends particularly well with bergamot, lemon, mandarin, grapefruit, neroli, orange blossom, petitgrain, lavender, rosemary, basil, jasmine, white flowers, vetiver, cedarwood, musks and light amber accords. In Mediterranean compositions it adds citrus brightness, floral softness and green-woody depth.

5. RECOMMENDED USE

General recommended concentration in perfume compositions: 5-20%. The appropriate level depends on the desired intensity, composition and finished-product category.
